Cochrane, Alberta T4C 2G1. They have a beautiful large Chapel Room with a well maintained grand piano and a whole wall of windows facing the Rocky Mountains.

Free and easy to use parking.

DATE AND TIME: Saturday May 27th, 2-3pm.

BUDGET: Their charge is \$150 and that leaves me \$50 for the Programs.

**4.3 ACRA** - Report - Naomi Williams <u>armtahonoursrecital@gmail.com</u> Frances has the ACRA cheques and will bring them to the recital. She also has 2 Harold Saklofske Scholarships (\$250 each) cheques. ACRA Report:

- cheques have been received from Judith at ARMTA in Edmonton

- Frances has the ARMTA Calgary cheques

- spoke to Brent Saklofske Jan 9 to explain why teachers have to be ARMTA members to win his award. He is going to get back to me with another name. When he does I'll get him the final details for his attendance at the event.

- Maryellen is working on the programs. I have supplied everything she needs except program order, the name of Brent's other pick, and the names of anyone participating in the Graduate Ceremony. I will edit the program, as well. I was not planning on printing any hard copies - I wanted to have QR codes and would also have the link to the program on the website, and emailed out to the participants the night before. This gives us flexibility to add volunteer names, fix typos, make program changes, etc, right up to the very last minute. If the board does not like that idea, please make arrangements to have the programs printed, picked up and delivered to the Temple at 3pm on Jan 28. If you want them printed, Maryellen will have the program completed by Jan 20.

- I have received 3 videos for the YouTube recital - the deadline for submissions is the 16th - we will premiered the online recital as a teaser for the live event via email and on the website on Jan 23

- Medals have been ordered. I am waiting for an ETD, and an invoice.

- I have to draft up and print letters to stuff along with cheques for our scholarship winners

- I plan to visit the Temple to get an idea of seating plan/setup/if we should/should not have food (is it covered in our insurance - if someone eats something and has an allergic reaction?)/power, hopefully by the end of this week. I am waiting for a reply from them.

- I plan to provide the PA from my studio equipment. We just require a small monitor, sound board and a couple mics/mic stands, and I can supply that. If the board does not like the idea, please make arrangements to rent a PA from somewhere, picked up and delivered to the Temple at 3pm on Jan 28, and then returned on Jan 29

I will be emailing teachers who volunteered to help me after I meet with Danny at the Temple and know what kind of help I need. Hopefully I will have all my helpers lined up by Jan 23.
I had always assumed I would be the general MC for this event , but is there someone from

the board who will be in attendance, and wants to thank advertisers, scholarship sponsors, make speeches about the donors, etc? Is it appropriate for my name not to be listed as a volunteer on the program, but as the ACRA Chair/Convenor? There is also another name listed next to mine...who is that person? Can I give them some of this work?

- I emailed Frances all kinds of summaries at the end of December around scholarship budgets, program length, etc.

Here is the email I sent to Barb last week to be sent to membership re: the Graduation Ceremony. I don't think it was ever sent on (or if it was, I didn't see it when the other ARMTA Calgary emails went out earlier this week).

At this point, I need the board to decide if we can this portion of the event, or if we just don't have the graduates listed in the program if you want it printed. If you decide you are okay with the digital version/QR code, then Barb can send the email out this week and just adjust the dates.

At the very least, it would be good to know who is graduating, so we can send them an email or a formal letter inviting them to join the chapter. To be sent to membership:

Teachers of students who graduated from RCM, CC, LCM, etc. between Sep 1, 2021 and Aug 31, 2022 may submit to have their students be honoured as part of the ARMTA Calgary Recital and Awards event on Saturday, January 28, 2023 @ 4pm in Calgary at the Temple B'Nai Tikvah (900 47th Ave SW). For your student to be eligible, you must be a current ARMTA Calgary member, as well as an ARMTA Calgary member during the eligible time period mentioned above.

Recent graduates can walk the stage to receive a certificate and a letter of invitation to join ARMTA, and have their culmination of music studies acknowledged in front of an audience.

The CFMTA has been busy and you should have all received our January 1, 2023 Email "Of Note" with news of our 2022 accomplishments, Young Artist Tours, upcoming events (including Branching Out), deadline dates for Composition Competition, National Essay Competition, Hughes Ferguson Distinguished Teacher Award, and the Memorial Pedagogy Award. Among others. There was further news about the CFMTA National Conference "Our Rhythm Runs Through It" being held in Edmonton July 5 to 7, 2023. The Winter edition of the Canadian Music Teacher Magazine is now online also. And the monthly "Connecting Canada" one-hour Zoom meetings are really fun, drop in sometime - or check the website for the "notes" from past meetings. The next session is Friday January 20th and the topic will be "Tax Tips for Teachers".

On a different note, I am Co-Chair of the CFMTA "Program Funding and Grant Committee" and CFMTA has recently purchased a 16 month online "Grant Advance" membership. # DISCUSSION:

Preamble: There has been a request for a Medicine Hat student who has a Calgary teacher, to compete in the Calgary competition. Medicine Hat is outside of the regular competition boundaries. There seems to be one performer each year who wants to compete in Calgary. I have just given my personal opinion but have asked for more time to get board input. I have read the letter from the parent who has very valid reasoning and as she mentions, there has been precedent. Here is my part of my response to Rotary C3 steering committee.

• As the Calgary branch is the one supporting C3, it is great to support a Calgary area student and teacher and even better if it is an ARMTA teacher.

• It is unfortunate that the student does not live in our area, BUT, did live here previously.

• The student is supporting a Calgary teacher, although, is John a resident here, or in the states. (I know one of the teachers is often teaching in the states.)

• It is unfortunate that John is not a member of ARMTA provincial, or Calgary.

• Although we like to support our members and their students, it is also important to us to reach out to other students and teachers.

If the Calgary branch is not in favour, I will also ask if we can access provincial funds for this competition.

Right now membership is \$135 after October 1: use discount code: half year You do not have to belong to the Calgary branch to be a member.

Thanks for the info, I will delete those codes. Something to consider; after January 15th, memberships are pre-approved to start April 1st so we don't get many this time of year. Perhaps a policy for future years could be similar to provincial, we offer a discount of \$50 (off \$185) after Oct. 1st for new applicants. Other branches do not offer these discounts, and you are welcome to charge full price if your branch chooses to do that. The only branch that offers discounts on membership is Lethbridge has first year free. Calgary and Edmonton Branch both offer retired memberships for half price.

Membership Discount - Frances / Tamara

Today, there was another application for Calgary Branch. I'm happy to still be receiving applications for membership this time of year.

I want to bring to your attention that when someone applies now in provincial they receive a \$50 discount because there are only 4 months left in the year. However, they are asked to pay the full fee for Calgary branch of \$65. No one has said anything, and if they really want to join, they pay it, however, it may be something to consider.

# 5.4 Report for Branching Out: Nathene & Barb

Committee Members: Carolyn Steeves, Barbara Robertson and Nathene Arthur

Our Committee met on December 13, 2022. We had a discussion of possible venues, events and dates. The theme is "Collaborating with the Arts & Beyond". We have come up with a Plan A, Plan B and if all else fails Plan C.

The Date will be: Sunday March 12, 2023, 7-8pm, with an ARMTA Social to follow. Barbara will check out the availability of the St Thomas United Church in Hawkwood.

PLAN A:

Baroque Dance lessons for teachers and students. Barb and Carolyn are contacting a few dance instructors. Barb would get an announcement in the Impromptu about "Branching Out event happening Sunday March 12th, 2023 - details TBA."

If the Baroque Dance lessons don't work out, we have our Plan B.

PLAN B:

Similar to above but with "Ballroom Dancing" instead of Baroque dancing.

If that also proves too difficult, we have our Plan C.

#### PLAN C:

We will hold a Schubertiad social event and invite ARMTA and non-ARMTA musicians to a social where we bring instruments, poetry/speech arts, painting, dancing etc. and generally "collaborate" with such (to be decided in advance) themes as lost love, Canadian history, duets etc. It could be quite fun.

Funding: while CFMTA will pay \$100 "after-the-fact" we are hoping to be able to access some Calgary ARMTA Workshop/Event budget money also. Our budget would be under \$300.

ACTION ITEM: To ask for a maximum of \$300 to hold this "Branching Out Event", given through our Workshop Budget.

Update from Barb - We would have to make a donation for the use of the Church - probably \$100 would be a good suggestion.

More developments from the dance studio:

-They have suggested that some of our students - maybe 5-10 could each accompany some dancers as they do some of their set work. We could also get a pianist and violinist, etc. to collaborate and play together. the dancers would get to dance with live music, and the musicians would have a chance to experience playing for dancers. (THis is one way my daughter paid for her University - playing for dance classes.)

-The dance teachers would lead the ARMTA kids (with help of the dancers) in some steps.

- I will also ask the studio if they could do a little demo for jazz, tap, contemporary...

I would suggest that this be open to students, ( as well as teachers, and parents) to observe, with some ARMTA students doing the playing, and all ARMTA students trying the dance combo.

I will be away for most of February so am going to have to pass this on to someone else for finalizing details.

Nathene - I like the idea of having some of our students (and or teachers) take part in the dancing. Would they sign up in advance for this?

And could we get an exact number of how many such dancers we could accommodate? We return on Jan 20th. I am unsure about watching jazz Tap or contemporary....

Brainstormed how

- Importance of personal and individual contact by phone or by email
- In person get together
- House parties
- Zoom party
- Social gathering with a speaker or performer as the draw perhaps use March 12 Branching out event

Brainstormed what

Acknowledge/name/ introduce conveners and board members Reiterate the importance of volunteers to our organization Name things the Branch does/ offers (recitals, awards, scholarships, support of festivals, RC3) Explain acronyms What is on the website, where to find, how to navigate Ask what do you want/ how can we help Desire for single list of events

Other

- Need better orientation for new board members at either the May or June meeting: board roles, convener roles
- Need more communication with conveners: maybe invite 2-4 to each meeting to be introduces to /board members and to talk about what they do or ask questions of the board.

Some decisions/ recommendations

 Use dates in March, aiming for one party each week-- maybe call the campaign March Madness

- Offer 4 house parties, one in each quadrant (maybe in satellite communities) and at least one online party. Expect 5 -15 (cap at 15 or let host determine maximum?) people at each party.
- Need a host (home and light snack cost covered by branch, budget amount?) and a facilitator for each party. The number of facilitators and hosts will determine the number of parties.
- Host provides a place (their home), beverage and light snack (Board determine a \$\$ amount), contacts confirmed guests to welcome and provide address/directions, maybe do a formal welcome and introduce facilitator
- Facilitator will mange the discussion and presentation of information. Try to keep to an hour or less. Suggest facilitators be members who have multiple experiences on the branch board and maybe provincial or CFMTA -- Beth, Barb? Nathene? Lisa Kiernan? Carolyn
- Offer at least one Saturday afternoon or evening, one Sunday afternoon or evening, one weekday morning and one online
- Try to have at least 1 board member and 1 convener at each party.
- Give each party a theme: Navigating ARMTA Websites, Volunteer Opportunities what do you need to know, What does the ARMTA Calgary Branch Do? Who's Who in the ARMTA Zoo ...
- In fact each party should be able to have the same list of objectives, but each part will come at the information from a different point of view.
- Contact every member with an invitation to find out more about Calgary Branch
- Contact conveners and board members first for commitment to attend (maybe host or facilitate) at least one party.
- Recommend an email to a group of 15 recipients first. Follow up with a phone call and one follow up phone call. (Alternately follow up with an individual email.)
- 180 members. Divide membership list by quadrant (SE SW NE NW). Could each board member make about 15 calls? 15 calls can be made in under 2 hours, and another time to make one follow up call.
- Attempt to get a commitment to attend a party.
- Be willing to talk about the Branch
- Be willing to listen to concerns and bring them back to a board meeting.

To do:

- Create a sample email
- Create a sample phone script
- Create a list of talking points/objectives for the facilitators
- Provide a time for facilitators to practice presentation.
- Head shot of board members and conveners

## 8. REPORTS FOR DISCUSSION/ACTION

#### 8.1 Canada Helps Report Beth

I was just doing annual donations using Canada Helps.

I looked at ARMTA Calgary's Endowment Society Canada Helps page. Please check the "Our Impact" page which uses information from CRA to create a graph profile showing how much has been spent on fundraising, management, projects, and "gifts to qualified donees" (gifts to other registered charities). The information up to 2019 reflects what I believe we were doing. But it would appear that CRA does not have good information for 2020 and 2021.

I don't know how to rectify this, or who should look into it. But it would seem that we could be endangering the society's "charitable' status with incomplete reporting. We may need Sharon Carne's help with this to get back on track.

Lorna: "I will look into this as soon she can. Just looking at the CRA returns from 2018-2019 to 2021-2022. All of these returns include:

Honours (ACRA) Recital scholarships; outstanding student (OSR) scholarships; endowment society projects (Music marathon, Music for everyone)

The total expenditures on programs and scholarships:

Year ending 2019: \$21,842 Year ending 2020: \$9,361 Year ending 2021: \$\$491 Year ending 2022: \$9,303

It seems to all track with what the returns reported and what Canada Helps shows as our expenditures and income. As Maryellen said, the 2021-20222 information likely hasn't been submitted to Canada Helps yet. I imagine that 2019-2020 and maybe even 2020-2021 was lower due to the pandemic impacting program delivery and expenses (online)

Would you like me to re-do the return for year ending 2021 to see if anything is missing as compared to the financial statements?"

#### 8.2 Joan Bell Scholarship - Beth

The parameters for the scholarship in honour of Joan Bell are yet to be determined. Other than agreeing that this is a one time scholarship of \$100 from the branch. It should go to piano, maybe a senior because that was Joan's specialty. If there is nothing else, then at this late date perhaps the convener can make it "convener's choice"

Naomi - I'd like to suggest the female musician with the highest practical (or combined) mark should be the scholarship recipient. I think something like that would be appropriate, and easy to award with little politics.
