BOOKKEEPER'S REPORT: Nothing to report.

TREASURER'S REPORT: In my pursuit of the CRA's confirmation of our Registered Charity Information Return (form 23010) I spoke with a representative of the Charities Directorate. Phone contact for client service is 1-800-267-2384. Two topics came up:

1) When there is a change of directors in the Endowment society, it is necessary to change the names on the CRA directorate's "internal list of directors". This is different than the list we

include with our returns. Currently there are no names on this list for our society and hasn't been for some number of years. Being on this list will enable the current directors to have access to the CRA online after creating a "My Business Account", or by phone. This will enable us to do our returns online as well as well as speak with a CRA rep by phone regarding our society. The list of names must be sent to Directorate of the CRA, Ottawa, Ontario K1A 0L5. It will not reach them if we send information to Summerside, PEI with the return. I sent a letter to the Directorate on November 3rd requesting that Sandra Joy Friesen as chair, Angela Frankowski as Vice Chair and myself as Treasurer be added to the "internal list of directors" for now. This will be updated when the next return is sent after the AGM and before August 28th. The names we give the Directorate for their internal list is up to our discretion.

2) The second item is regarding the "Mailing Address" update. We have been trying to change this for a few years with no success. I finally found out why. We have been sending the change of address with the CRA return to Summerside, PEI but we should be sending any changes to the CRA Directorate in Ottawa. I included this in my Nov 3rd letter. The address I gave was mine as Treasurer.

4c. Past Chair Report, Beth Olver

For information: catering, email password policy added to documents, Archives, Vacancies Follow up on **catering**

I emailed Nadia with our concerns about expenses:

On Wed, Oct 25, 2023 at 12:54 PM beth olver <<u>betholver754@gmail.com</u>> wrote: Hello Nadia,

We thank you very much for your willingness to supply food and drink to our Branch events and your desire to provide a good variety of food and cater to special diets like gluten free is greatly appreciated.

However, the board has concerns about how much has been spent and how much has been left over from the catering events in May and August. Perhaps there has been some failure to communicate how many were expected at the events or what is wanted for most of our catered events.

In April you requested an increase of 30% per person to \$3.25 per person and the board agreed. Therefore, for a gathering of 15-20 people the maximum catering expense will be \$65. We are looking for a light snack or "coffee break", not a meal. Our gatherings are usually between breakfast and lunch times. So, coffee/tea/water and a snack (such as one of these: a square of cake, or a couple of cookies, or a small serving of fruit and a little cheese, or cheese and crackers, or Timbits, or a small muffin). We believe that a drink and a small snack will easily stay under \$3.25 per person.
