## 6.2 Bookkeeper Report, Maryellen

Sharon Carne: Treasurer from approx. 2012 to May 2020 Denisha Teichroeb: Treasurer from May 2020 to May 2021 Lorna Sewell: Treasurer from May 2021 to May 2025

I recently filed our CRA return and I also requested that they change our mailing address. They phoned me today (August 13) to tell me that they are unable to change our address because I am not listed as a Director.

Following the example of Sharon's CRA filings Lorna and I have always listed each board member as a Director. We left me off because I am not a member of ARMTA. Today I learned from the CRA that it is only our internal rules and bylaws that dictate who is a Director. Our bylaws don't contain the word "Director" anywhere, but I believe the following three points are relevant in this case:

- **5.7** The Officers shall be the governing body of this Society and shall have full control and management of the business and affairs of the Endowment Society of the Calgary Registered Music Teachers, and will report to the Board.
- **5.1** The Officers shall consist of the Chair, Vice Chair, Secretary, Treasurer, and two additional members of the Calgary Branch of ARMTA or the general public.

**5.2** Board members shall consist of officers, additional individuals and conveners, and an (paid, non-voting) Administrator. In the case that the Administrator is an ARMTA member in good standing they shall retain voting rights.

Questions: Who do the "two additional members" refer to? SHOULD SAY MEMBERS AT LARGE

And what exactly is the meaning of "the general public"?

Are the Directors the same people as the Officers? YES change 5.7 or 5.

Could we revise the bylaws to answer those questions? And in order to provide clarity to those who prepare the provincial and federal returns, could we define "Director" and add a paragraph stating who the directors consist of? Also, I strongly believe that the Bookkeeper should also be considered an Officer. Since the Bookkeeper and the Secretary are the same person, could we change 5.1 as follows?

**5.1** The Officers shall consist of the Chair, Vice Chair, Secretary, Administrator, Treasurer, and two additional members of the Calgary Branch of ARMTA or the general public.

For the last three years, the following has been an outstanding bylaw revision:

6.3 of Sept 2022 Minutes have the policy change regarding who is eligible to sign cheques. 5.1 of Oct'22 Minutes says hold off on making the same change to the Bylaws until such time as there are other changes to present to the Registry.

Add ACTION ITEM to the September 15 meeting minutes: Maryellen will inform Lorna that the CRA will maintain her address until next year when I file the next return.

## 6.3 Desktop Publisher Report, Maryellen

On April 14, 2025, the board agreed to discontinue the sponsorship honourarium this year (after paying Jackie Law). She was paid \$300 per year for substandard work.

Andrea Case, the new sponsorship convener has taken over and has already obtained nine new advertisers. She herself has opted to run two advertisements with us:

\$200 Andante level for Kensington Sinfonia

\$200 Andante level for Lily String Quartet

She has secured an additional \$2900 in revenue over what the previous convener was bringing in.

Would the board be interested in implementing an offer to cover the cost or portion of advertising cost to each sponsorship convener per year? And if so, would this be written into the Sponsorship job description or the Policy & Procedures manual?

#### 6.4 Secretary Report, Maryellen

I try to keep our administration fees low, but everything is so expensive. I applied for non-profit pricing for both Zoom and Adobe, but was rejected. They both determine eligibility through "Goodstack". There was no reason provided for the rejections, other than to say that they look at "certain types of activities the program is aimed at and having nonprofit status doesn't automatically grant eligibility".

Last year, I was able to secure a half-price **Zoom** subscription through TechSoup. Unfortunately, this is no longer offered. Therefore, Zoom will be full price this year and our subscription is set for auto-renew on Sept 12. The cost is of 214.90 plus GST.

There is an inconvenience to not having the Pro version of Adobe Acrobat. The branch approved me for a \$65 subscription in March and I recently went to sign up and learned that the fee is much higher than I thought. It looks like the fee is \$311.88 per year plus GST and I am requesting for approval of this expense.
